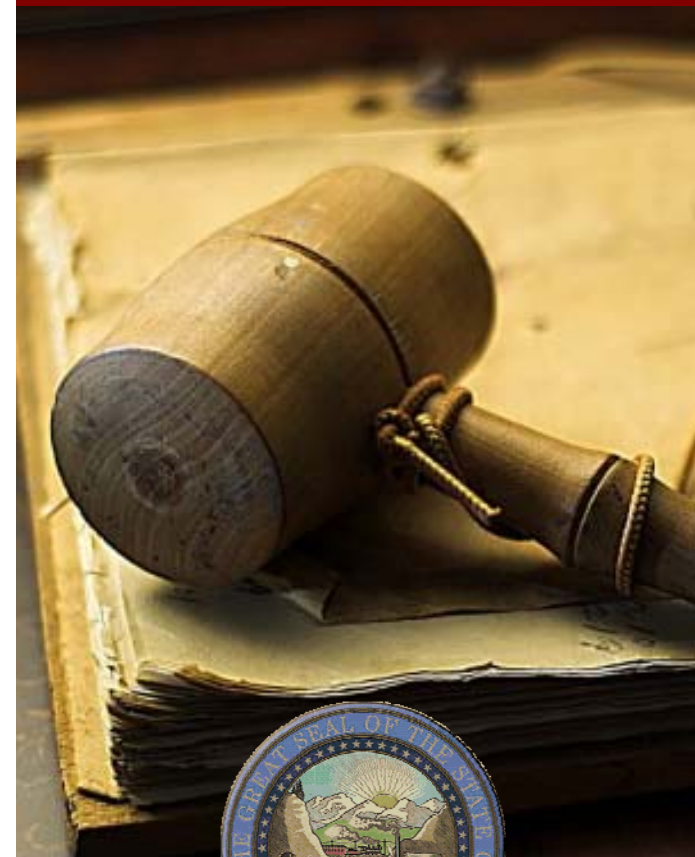

The Division of Child and Family Services (DCFS) Youth Parole Bureau provides supervision and case management services for:

- Youth, 12 to 18 years, who are committed to DCFS for correctional and/or mental health care.
- Youth, 12 to 18 years, who are committed to DCFS for correctional care but cannot by law be placed in a correctional program.
- Youth transferred to Nevada through the Interstate Compact on Juveniles.

How Youth Parole Works

- Nevada Youth Parole begins with a comprehensive client assessment which identifies appropriate treatment, placement and services needed to promote success and accountability.
- Nevada Youth Parole works closely with our state correctional facilities and providers to ensure each youth is receiving services to address their rehabilitative goals. Reintegration back in to the community is a key time for the youth and their family.
- During this period of transition, Youth Parole Counselors provide supervision to promote lawful behavior and ensure success at home, in the classroom and within the community. Where appropriate, youth are encouraged to seek and maintain employment so that any remaining restitution may be paid to victims.

DCFS' Youth Parole Bureau also strives to provide family driven care. Family-driven means families have a primary decision making role in the care of their own children/youth, as well as the policies and procedures governing care for all children/youth in their community, state, tribe, territory and nation. This includes:

- Choosing supports, services, and providers
- Setting goals
- Designing and implementing programs
- Monitoring outcomes
- Partnering in funding decisions
- Determining the effectiveness of all efforts to promote the mental health and well being of children and youth

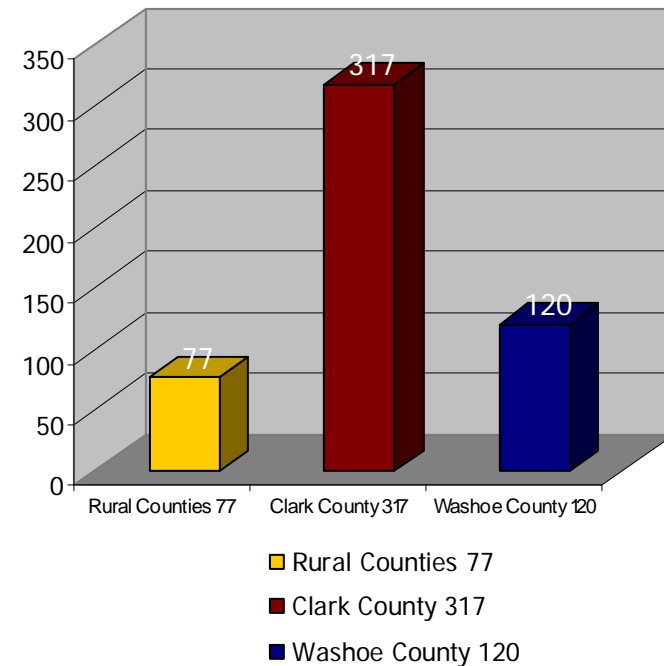

Services provided by Youth Parole Counselors include:

- Gender Specific Counseling
- Sexual Offender Counseling
- Drug and Alcohol Counseling
- Crisis Management
- Mentoring Supervision
- Evening reporting (assists parole clients during at-risk hours)
- Electronic monitoring
- Educational/GED Preparation
- Vocational Preparation
